The individual counseling sessions varied in methods and intensity relevant to the individual's problems, ranging from complex family circumstances and behavioral issues to developing new adjustment techniques. I had to

think strategically and creatively to recommend adequate courses and goals for students to meet. I created systematic course of actions for each student progress report review to ensure completeness.
